Minutes of Meeting

Date: Monday 12th December 2011

at United Reformed Church, on the corner of the High Street and Manor Road, Rusthall

Present

1. Apologies for absence.- Apologies received from Councillor J.Clark

Announcement by the Chairman of the resignation of Councillor Kelly Watson. The Chairman read out the letter of resignation which was addressed to the Chairman and said:-

'I am writing to offer my resignation as a Parish Councillor for Rusthall Parish Council. I feel that due to external pressures that I am unable to give my time to the position and feel that someone else would be better suited to the role.'

- 2. Declaration of Interests.
 - 2.1 Councillor Lawrence declared a personal interest in item 8 as he is an allotment holder and Councillor Simmons declared a personal interest in item 9 as her children attend Bishop Down School.
- 3. Minutes of the meeting held on the 14th November 2011 were agreed.
- 4. Session for County and Borough Councillors
 - 4.1 County Councillor Davies reported that Kent County Council had to make budget savings of £95M this year. County Members were also looking at a new structure for the County Council which sought to involve backbenchers in more decision making. Councillor Davies also confirmed funding to resolve the erosion problems at Harmony Street.

- 4.2 Borough Councillor Atwood also reported budget issues at Borough level. It was necessary to make up a budget deficit of £350,000 for this year. Councillor Atwood confirmed Borough council support for the improvements at Harmony Street. He also indicated the Borough Council was also looking at structures which would involve backbench Councillors in more of the Council's decision making.
- 4.3 Borough Councillor Webb reported on a number of areas in which he had been involved including lobbying Kent County Council to get the problem with the drain in the High St resolved, lobbying Highways re the potholes in Rusthall Road. He also informed the Parish Council of all the meetings he had attended and representations he had made at those meetings.
- 5. Open session for members of the public. A query was raised about a sign giving directions to the Pantiles had been taken down.
- 6. Report from the Planning Committee.
 - 6.1 The report from the Chairman of the Planning Committee (Councillor Edwards) set the Parish Council's statutory responses to four applications which had been received since the last meeting.
 - 6.2 Application 2 Rustwick 2 storey extension recommendation approve under Officer delegation.
 - 6.3 Application 11 Redland conservatory recommendation approve under Officer delegation.
 - 6.4 Application 21 Erskine Park 2 storey extension recommendation approve with condition that shared driveway be kept clear.
- 7. Notice Board It was noted that the Notice Board site had been measured up and it was hoped it would be installed later that week.
- 8. Allotments Update It was noted the Working Group would be meeting up with representatives of the three allotment sites to discuss future arrangements.
- 9. Still Green Boardwalk

- 9.1 A motion was moved that Rusthall Parish Council support the proposal for investigative drilling at the site. This motion was rejected by the Parish Council (4 against, 1 for and 2 abstentions)
- 9.2 It was resolved unanimously that Rusthall Parish Council would work with other partners to ensure that the path at Still Green is improved (subject to that part of the path being located within the parish).
- 10. Rusthall Precept The precept for Rusthall as set out below was approved.
