5. Minutes of the Parish Council Meeting held on the 10th July 2023

6. Open session for questions from the public

Mr Mick Heasman, Chair of the local Speedwatch group said;

- Reference Agenda item 12. Calming measures Cranwell Rd: Mick informed the meeting that Kent Speedwatch guidelines state that there must be a clear line of vision for a Speedwatch activity to take place. This isn't possible in Cranwell Rd, due to on street parking on both sides of the road.
- Mick has previously written to TWBC regarding traffic calming measures in the village which have been previously reviewed and as yet no follow up.
- 20mph, ongoing issues regarding signage of 20mph zone which currently do not meet traffic regulations. KCC have been contacted and as yet no response has been received regarding these being improved or for the Parish Council to 'self-manage' bringing them up to the required standard. It was suggested that maybe the Council should respond that 'we will self-manage unless we hear to the contrary'.

Ms Helen Foster said:-

- Has still not had a reply regarding tree that was 'illegally' taken down in the garden next to The Red Lion public house. There has been no response from the Tree Man or from Parish Council. She would like this followed up.
- Meadow Road hedge adjacent to the betting shop is sprouting long bramble branches, these are a hazard to pedestrians. The betting shop has been asked to cut these back. Cllr Paul Gripper to speak to betting shop and offer to cut these backs.
- Lower Green Road repair to badger damage of wall. Repairers have run out of stones and the repair will be finished in due course.

- **8.2** Christmas Lights: It was RESOLVED to accept the quote of £2560 from Festive Decorations Ltd to prepare, install, and take down Christmas lights on 10 lamp posts along Rusthall village high street. Deputy Clerk was asked to submit a short list of lighting designs for the councillors to choose from.
- **8.3** Grant Application: It was RESOLVED to award the Grant request of £450 to Rusthall Bonfire and Fete Committee for family entertainment at the Summer Fete. (Cllrs on Bonfire & Fete committee abstained).
- **8.4** Dropped Kerb: It was RESOLVED to accept £200 cost of painting white lines to mark the new dropped kerb at Southwood Road allotments.

9 Allotments Committee:

- **9.1** It was RESOLVED to accept the quotes totalling £3000 from B.Akehurst to install the dropped kerb, and tarmac the adjacent grass verge at Southwood Road Allotments.
- **9.2** It was RESOLVED to accept the UKSPF Grant agreement, its terms and conditions. Which Cllr Mark O'Callaghan, as Vice Chairman duly signed on behalf of the Council. A vote of thanks was offered to Cllr Liz Ellicott who completed the complex Grant application.

10. Planning Committee Meeting

It was resolved to adopt the minutes of the meeting on 12th June 2023.

11. Defibrillator Update – The defibrillator at Toad Rock is in good working order. No update regarding the one at URC church.

12. Highways Updates:

- **12.1** It was RESOLVED to approve the applications for the disabled parking bay in Erskine Park Road and Valley Road. (Cllr Paul Gripper abstained from the Erskine Pk Rd vote).
- **12.2** Emerging Local Traffic Plan: Cllr Paul Gripper reported that there is a KCC consultation document available to review and comment on, date closes on Monday 18th Sept.
- **12.3** Traffic Calming in Cranwell Road: Cllr Paul Gripper will reply to the resident who wrote to bring issues to the Council's attention.
- **12.4** Pedestrian crossing on A264. Cllr Paul Gripper reported a disappointing response to his letter. Responses within the letter do not consider public safety but are data driven. The Commons Conservators Committee are working towards a standard speed limit of 30 mph across both Tunbridge Wells and Rusthall Commons. the issue is moved on and plans to set up a meeting here in the village with KCC Cllr James McInvoy, Nigel Rowe and Emma Tilbury to illustrate and discuss the issues and open discussion about available options to implement effective traffic calming. Cllr Paul Gripper has also written to MP Greg Clark seeking his support.

Cllr Paul Gripper also plans to raise the issue of the incomplete implementation of the 20mph speed limits around the village.

- 13. Commons Conservators: It was RESOLVED to accept the offer to relocate a bench from Tunbridge Wells Common to the grassed area in front of St Pauls Church near the red chestnut tree.
- **14. Rusthall Volunteers:** Cllr Mark O'Callaghan stated there were no updates to report. He will be sending out a letter and has spoken to Cllr Warne from Tunbridge Wells Borough Council who has shown interested.
- **15. Rusthall Civic Plaque Nominations:** Cllr Dave Funnell proposed a schedule of candidates for the erection of a civic plaque.

The candidates suggested are:

Denis Penfold – History Society

Mark Rees – Involvement with national transgender policy

Roy and Rhoda Radcliff - Large donation of funds to the Council.

The Council RESOLVED to initially proceed with planning for a plaque for Denis Penfold in consultation with his family, with additional plaques to be installed in the future.

- **16.** Chair's Report Councillor Ellicott met with Conservators regarding Big Litter pick to take place on morning of 28th October.
- 17. Officers' Report Deputy Clerk Linda Neusten reported:-
 - That Clerk Alison Stevens had met with CEO of KALC to promote activities being carried out here in Rusthall Parish Council.
 - That a Staff meeting was held to review the restructure implemented 12 weeks ago. Meetings will now be held regularly every 3 months.
